

2021-2022 Year End Report for Luke Chapter MOAA

1. Legislative Affairs

A. Legislative Liaison, Colonel Phil Hanson, a former member of the Arizona Senate, kept members informed with a steady stream of emails and on-going status reports of bills in the state legislature. Captain Denny Bash who serves on Rep. Debbie Lesko's Military Advisory Board provided additional updates on his role in that position.

B. Several Blast emails to you kept the membership informed of **pending legislation** and many of you called Arizona legislature members regarding these issues. Col Pete Kloeber (Council President) and LTC Darren Venters (AZ Council Legislative Chair) on behalf of our Luke Chapter and the Arizona Council of Chapters met with Representative Debbie Lesko regarding National MOAA legislative priorities. Wearing both hats as a MOAA National Board Member and as a Luke Chapter Board Member, LTG John Regni also participated with Pete and Darren promoting "Advocacy in Action" to CW Debbie Lesko (and he reported she was very supportive).

2. Community Engagement

A. For the fourth straight year, you actively supported the **Marine Corps Reserve "Toys for Tots"** program. Your generous donations provided well over 50 toys to this effort.

- B. You supported other very worthwhile programs supporting military veterans:
 - (1) \$100 to the <u>Arizona Honor Flight</u> program to support honor flights of veterans to visit national memorials in Washington, D.C.
 - (2) \$200 to the MOWW (Military Order of the World Wars) Leadership Academy
 - (3) \$250 to the Fighter Country Partnership (Luke AFB liaisons with local businesses)
 - (4) \$500 to the Arizona Stand-Down

C. During November 2021, your diligent Chaplain Fannalou Guggisberg coordinated and

provided a drop off site for the Luke Chapter <u>Turkeys for Troops program</u> which provided food and commissary cards to low-ranking Airmen at Luke AFB. **This year was another record setting year** as you donated well over 1,000 items for this cause, outdistancing last year's previous record of 900 items. In addition, \$1,500 (\$250 more than the prior year) in commissary cards were donated to make these young Airmen's Thanksgiving much brighter!



3. Community Support

A. Scholarships: Under the dedication and perseverance of the Scholarship Chair, Don Fordney, eighteen students received \$35,000 in scholarships to various institutions (\$5,000 more than the prior year). Scholarships ranged in size from \$1,000 to \$4,000 each.

B Veteran Support: For several years now, COL Mike Kramer has managed the veteran support program in an exemplary manner. Many thanks also go to the interview committees who extensively evaluated each applicant. Funding for veteran support came from National MOAA (\$7,500), Arizona Department of Veterans Services (\$4,999), Corporate donors, friends of the Chapter, and most importantly your donations. This year, 31 veterans in need were supported in one way or another, with total grants exceeding \$38,000. C. **Fund Raising** (For a complete listing of donors, please see Appendix 1):

(1) Your Luke Chapter Community Fund led by LTC Ed McAvoy, held the Second Annual Chapter online auction on April 2, 2022, and raised a total of \$5,479.48 (an increase of \$1,630.42 over last year) from items you donated! Many thanks to Chaplain Guggisberg for offering her home, keeping an inventory of all items, and for coordinating everything to make this a big success! Monarch Auctions headed by Robert Haynes conducted the Auction at no cost to the Chapter (please thank him and recommend him!)

- (2) There were 72 individual donations of \$41,858! Even though this was less than last year, it was a significant amount! Many thanks to everyone who donated!
 - (3) Twelve **corporate donors** provided \$8,400 (up \$850) to your Chapter.
 - (4) Non-Member donations added \$1,818 to the totals.
 - (4) Total donations for 2021-2022 fiscal year: \$57,555.48 (Up \$2,061.42)
 - (5) Special thanks go out to Mrs. Pam Wojtas for over 100 thank-you letters to donors!

4. Recruiting and Retention





considerable recognition in the State of Arizona and MOAA wide. It was quite an honor to have Linda present a great overview of the new program to the Arizona Chapter at one of their meetings.





6. Programs

Your first dinner meeting program of the year started in November with former News Anchor Lin Sue Cooney representing Hospice of the Valley. Then in December, Thaddeus Rose again provided exceptional music at your Christmas dinner-dance. In January Dr. Eduardo Pagan, star of the PBS History Detectives series provided a great WWII Nazi spy story. In February, Steve Hosa had a particularly interesting presentation on the WWII Papago Park POW Camp. In March, COL Mark Tillman again joined us for more exciting stories about his experiences as the AF One pilot on 9/11. Belinda Gail,

America's Western Sweetheart sang her heart out in April and chapter member RDML Steve Kunkle ended the year explaining his role as Task Force Commander of Carrier Strike Group 5 during the Afghanistan war.

9. Awards and Honors



A. **Five-Star Chapter again!** Yes, you did it again! It was just announced on August 19, 2022 that your Luke Chapter has achieved a five star Levels of Excellence Award for the <u>sixteenth year in a row</u>. Congratulations to all who worked so hard to make this happen! Awards are reviewed by a board of officers based on Objective (45%) and Subjective (55%) scoring. Objective scoring is based on percentages of key

chapter officers who are members of National; number of chapter members who are a member of National; use of the Committee Module for recruiting; designated Legislative and SSp chairs; the

chapter is enrolled in Electronic transfer of funds; if the chapter belongs to the state Council and the Chapter President receives the MOAA Newsletter. Subjective scoring includes active legislative affairs program, community engagement, recruiting and retention, leadership succession plan and 10 points of extra credit for innovative programs, events, and other outstanding community outreach.



B. Marvin J. Harris Communications Awards: The Luke Chapter Website and the NewsGram both won five star awards again! Bob Nelson, who now resides in Pensacola, FL manages your Chapter website (www.lukemoaa.org) in an outstanding manner. Scott Phillips also does a super job of providing a great NewsGram eight or nine times a year! Several years of past NewGram's are available on the website and make for extremely interesting reading! Be sure and

C. Induction into the Arizona Veterans Hall of Fame: This fiscal year, <u>chapter member Captain Denny Bash</u>, was inducted into the Arizona Veterans Hall of Fame. As of June 30, 2022, sixteen Chapter members have been inducted since 2003 (go to: <u>www.lukemoaa.org</u> (Local Interest) for a list of members.

10. Finances Financial Status is Strong.

- **A. Chapter Fund**: Your Chapter is in excellent Financial Health. As of 1 July, 2022, the Chapter Fund had a balance of: \$27,724.15. Of this amount, approximately \$8,000 in is restricted funds. Restricted Funds include Pre-Paid Dues and a National MOAA \$5,000 Grant.
- **B. Community Fund**: As of 1 July 2022, your Chapter Community Fund had a cash balance of \$20,170.74 (this is after all 18 scholarship checks have been taken out for 2022. The Community Fund also has a PenFed account which shows a balance of \$46,790.22. The Community Fund always has a reserve in case the Chapter would have a slow year.
